**NG ENERGY REACHES THE CIÉNAGA DE ORO FORMATION IDENTIFYING 100 FEET OF NET GAS PAY**

**VANCOUVER, B.C., June 28, 2022 – NG Energy International Corp. (“NGE” or the “Company”)** (TSXV: GASX) (OTCQX: GASXF) is pleased to announce that drilling at Magico-1 has reached the Ciénaga De Oro (“CDO”) sandstone reservoir encountered at 3,000 ft. The Company has identified several prospective gas bearing zones through well logs at a depth between 3,200 and 3,350 ft. for a total gross pay of 150 ft. and a net pay of 100 ft. The prospective zones will be tested during the coming weeks to define where and how the well should be completed.

Serafino Iacono, Chief Executive Officer of NGE, commented “We are preparing to test and complete the well and are very excited. We believe we will have good production from these tests and once complete be ready for the next exploration activities in this very prospective gas producing region.”
